TERMS:

All booth spaces are rented and services rendered are to be **PAID IN ADVANCE**. **Signed Contract and money must be in show manager's hands by Monday, November 21, 2005. Our US mail is not fast so don't wait until the last minute, PLEASE.** Spaces will be assigned on a "first come first served" basis.

Booth space shall be assigned at the discretion of the show committee, who will layout booth spaces as close to vendor's request as possible.

Vendor will be responsible for providing insurance. Neither the show committee, IHBS, PUFF, the City of Cape Girardeau nor the A. C. Brase Arena shall be liable for loss, damage or injuries that may be sustained by vendor for any reason.

Vendor will provide his own decorations or additional materials as needed in accordance with show rules and regulations and subject to the approval of the show committee. Staples or tacks may not be used in the tables. Vendors using noisy equipment or materials deemed, by IHBS/PUFF, to be noxious or harmful to exhibitors or cats, must be located away from the benching area.

Vendors may not accept delivery of goods during show hours.
